  - We are at mid-year and ahead of spending. They have had 44 fund requests totaling \$20, 693, leaving \$8,306 for the remainder of the year. They continue to use crisis funds whenever possible. Denise does not anticipate they will have funding left at the end of the year. The counties also have funds available for housing. Please coordinate with them to see if they can assist with requests received.

Scheduling: Flexible daytime, late into the evening (11pm), and Saturday hours

Customization: Specialized groups (LGBTQIA+, BIPOC, Neurodivergent, Military, Maternal Mental Health,

Trauma, etc.)

Wait Times: No waitlist; first group within 1-5 days (after verifying benefits)

Case Management: Post-discharge support & 70+ alumni groups

Insurance: In-network TriCare, most major commercial plans and BCBS Medicaid of MN and North Dakota

# The four ways to refer to Charlie Health:

- How do you involve the therapist in the discharge planning? Whatever is easiest for them. Some request meetings, others just like email communication through the planning.
- Do you do any testing- bio psychosocial assessment-they assess what groups and therapist will be the best fit for the patient. They complete the assessment for free and present to the patient prior to them accepting care.
- They are a great resource to help fill gaps. They can be a great resource if someone is on a waitlist to get into a higher level of care.
- They accept self-referrals

    - Cannot be submitted more often than 90 days
    - All revisions must be submitted on one form per funding stream (AMHI or CSP)
    - Budget revisions that exceed 10% require amendment
    - Always access request form from AMHI website to ensure correct version
  - Direct payment Update
    - Passed legislation
    - Implementation Goal Date: 2027
    - Could potentially impact application process
  - Grant monitoring
    - Review Grant requirements document
      - Shannon will start looking through the requirements and figure out what we have and compile documents to bring back to review at our meeting in September
    - Emails will be sent out over the next year and a half
    - Grantees will have two weeks to submit required documentation
    - DHS will have two weeks to review documents
    - Visit will be virtual and scheduled for two hours

      - Newly added statute language was approved with Direct payment: Subdivision 2. Program
        design and implantation. Adult mental health initiatives shall be responsible for designing,
        planning, improving, and maintaining a mental health service delivery system for adults
        with serious and persistent mental illness that would...
        - (5) utilize existing categorial funding streams and reimbursement sources in combined and creative ways, <u>except adult mental health initiative funding only</u> <u>after other eligible funding sources have been applied.</u>

- CSP: Sec. 245.4712 MN Statutes
  - Important statute language: Subdivision 3. Benefit assistance. Thae county board must offer to help adults with serious and persistent mental illness in applying for state and federal benefits, including Supplemental Security Income, medical assistance, Medicare, general assistance, and MN supplemental aid. The help must be offered as part of the community support program available to adults with serious and persistent mental illness for whom the county is financially responsible and who may qualify for these benefits.
- Sample Policy language
  - AMHI/CSP grant funds may be used to provide Medical Assistance-approved mental health services with Serious and Persistent Mental Illness (SPMI) who do not have insurance, or insurance does not cover service(s). This may include but is not limited to; Targeted Case Management (TCM) or Assertive Community Treatment (ACT) for uninsured or underinsured individuals who meet AMHI/CSP eligibility criteria when all other payment options have been explored or denied.

  - Sarah, Miranda, Brenda, Brenna, and Cheri went and met with FirstLink. It is a great service but is not comparable to the local Crisis line. They are actively resolving calls that come through 988. If you want faceto-face, you should call the regional Crisis line- 800.282.5005.

  - o 2025 AMHI budget
    - Norman Flex
      - Norman County has two officers that sit on the LAC and utilize most of their flex funds.
         They only have \$2000 left for the remainder of the year. Nancy is looking for additional funding to help cover this cost.
      - Directors agree that LAC stipends need to be moved to a different line item. Shannon will connect with Karen to move \$6000 from 402x Community Education & Prevention to a separate 402x County line item for LAC Stipends

  - Budget meeting- We will utilize much of our September meeting to discuss budget. Shannon will reach out to Karen for the deadline to submit bills to have the most up to date budget to review at our September meeting
