 - Opened their clinic in EGF two years ago June.
 - They have 59 clinics throughout the 5 States (IA, MN, MO, ND, and WI)
 - Current waitlist is nonexistent
 - o 54 Bed SUD Residential Treatment Facility- Big Lake
 - Therapy- Individual, group, couples, family & children
 - Psych & Med management
 - o DBT
- 9:45-10:15 Prairie St John's Presentation, Marita Payla
 - They have 132 inpatient psychiatric hospital beds for children, adolescents & adults
 - 44 Child & adolescent
 - 88 Adult
 - 48 supportive housing beds
 - Short walk away from St Genevieve's
 - Available to adults in both mental health or SUD in their Partial Hospitalization Program
 - Opened their new hospital in 2023.
 - They offer full psychiatric & addiction continuum of care.
 - o They provide care for the upper Midwest from Montana, Iowa, Wisconsin, North Dakota & South Dakota.
 - Families of Children can stay at the Ronald McDonald House.
 - Educational component offered to all through age 17.
 - o AA meetings offered to all adults Thursday's at 7pm.
 - Average stay is 7-10 days

- You are not required to go through the ED to receive prior auth before seeking care at PSJ. You can walk into their intake department or call 701.476.7200
- They can accept children ages 5 and up
- o St Genevieve's Place at PSJ offers outpatient mental health & substance use treatment
- o In network with most all major insurances, including ND& MN MA, Medicare & BHF.
- o Marita can pull data for us and would like to collaborate with this group to streamline care.
- 10:15-10:45 988 Partnership & Promotion Discussion
 - Group discussed marketing strategy around 988. They agreed that the HOPE Coalition and other groups can advertise how they would like but agree that we should market 988 as a warmline. Work on educational marketing on when you should call the regional crisis line versus 988.
