Provider Presentation	Alluma Crisis Team	Hannah from Alluma Crisis Team joined us-They Triage for the NW8 Counties. They respond to Alluma's 4 counties which include Polk, Red Lake, Norman & Mahnomen and Sanford covers Kittson, Marshall, Pennington and Roseau There is a screener and a practitioner on call 24/7. They have 4 practitioners and prefer face to face but also offer telemed. There are several scenarios they can refer out for substance use, outpatient, psych, and/or they do also offer Stabilization services which can last up to 10 weeks. They work on coping skills-DBT techniques. They also have a Crisis Peer that can assist clients as well. To work with the Peer, you must be 18 or older. They recently started their recliner program which is a 2 hour minimum decompress session. There is a short intake process. Massage recliners, weighted blankets, therapy lights and a snacks offered while there. Mon-Thur 8-8 and Friday's 8-6. They are moving from Gretchen Ave to the main Alluma building at Bruce Street. They no longer have Crisis Stabilization beds effective 8.1.2025.	Hannah Davidson
